Notice is hereby given that the City Council of San Elizario, Texas will hold a Regular Meeting on **Tuesday, September 26, 2017 at 6:00 p.m. at San Elizario City Hall, 12710 Church St., San Elizario, Texas** at which time the following items will be discussed, to wit:

### 1. Roll Call

### 2. Public Comment

The City Council welcomes public comments to topics not listed on the agenda. This segment is limited to thirty (30) minutes to the first ten (10) speakers. The City Council cannot respond to matters not listed on the agenda until placed on a future agenda.


